# QUICK REFERENCE FOR WAYNE COUNTY EMERGENCY RESPONSE PLANS

## A.PRIMARY RESPONSIBILITY

The Emergency Management Director will have primary responsibility to implement the County Emergency Response Plan.

## B.NOTIFICATION OF THE CHIEF EXECUTIVE

After notification is received of a hazard or a potential hazard, emergency or disaster, the Emergency Management Director shall notify the Chairman of the Board of Supervisors.

## C.NOTIFY/ACTIVATE EMERGENCY RESPONSE PERSONNEL

After notification is received of a hazard or a potential hazard, emergency or disaster, the Emergency Management Director will request that the Warning Point (Wayne County 911 Dispatch Center) implement the call-down list to notify/activate emergency response personnel. Activated personnel will immediately report to duty stations and/or to the Emergency Operations Center and/or the designated Command Center.

## D.STATE OF EMERGENCY DECLARATION

Pursuant to Article 2B of the Executive Law of the State of New York, the Board Chairman, the Town Supervisor or the Mayor of a Village may declare a local State of Emergency within any part or all of the territorial limits of the local government, and is authorized and empowered to use any and all facilities, equipment, supplies, personnel and other resources of the political subdivision to cope with the disaster or any emergency that results there from.
